In exercise of the powers delegated to the undersigned vide the second proviso to sub-rule (1) of Rule 23 of Goa Value Added Tax Rules, 2005, the last date for filing of quarterly returns for the quarter ending 31st March, 2020, "as a special case" has been extended upto 30th May, 2020. Accordingly, the assesses registered under the Goa Value Added Tax Rules, 2005 (Act 9 of 2005) either as regular dealer or as composition dealer are required to file their quarterly returns for the quarter ending 31st March, 2020 on or before 30th May, 2020; failure to file returns within the extended time shall attract penalties as provided in Section 55 of the said Act.

In exercise of the powers delegated to the undersigned vide the second proviso to sub-rule (1) of Rule 23 of Goa Value Added Tax Rules, 2005 (hereinafter called as the "said Rules"), the last date for filing of annual return for the year ending 31st March, 2020, "as a special case" has been extended upto 30th May, 2020. Accordingly, the dealers required to file annual returns either as regular dealer or as composition dealer, are required to file

their annual returns for the year ending 31st March, 2020 on or before 30th May, 2020; failure to file returns within the extended time shall attract penalties as provided in Section 55 of the said Act.

Order

No. 13/7/2020-I/PHD(Part)/774

In pursuance of Clause ix of Regulation 12 and Regulation 14 of the Goa Epidemic Disease, COVID-19 Regulations, 2020, the Government of Goa in order to prevent spread of COVID-19 in the State of Goa, hereby directs that all persons shall wear face cover compulsorily in all public places, work places including on streets, hospitals, working sites etc.

Any person violating above instructions shall be liable for penalty of ₹ 100/-. In case of non-payment, the person shall be liable for action under Section 188 of Indian Penal Code, 1860.

Explanation:- For the purpose of above "face cover" shall include mask available with the chemist or even home-made washable masks which can be used after proper washing and disinfecting them.

This order shall come into force with immediate effect.
