Sub.:- Appeal for encouraging cashless transactions.

Goa is likely to become the first State in India to go for cashless transactions from December 31. Even though cash transactions are not being banned, it is in the interest of the State to encourage cashless transactions.

Government of Goa has decided to take the next step of enabling cashless transactions for various receipts and payments being done in the course of day to day business and market related transactions including domestic and commercial purposes.

In this regard, an appeal is made to the manufacturers, retailers, wholesalers, dealers and other members of the trade, to encourage cashless transactions by making use of other available modes of payment/cash transfers like **Point of Sale Machines, QR code recognition and payment devices, Swipe card enabled payment systems etc.** A system of transferring money over mobile phone (which need not be smart phone) would also be introduced in the recent future. Banks are also requested to create awareness regarding the ease of doing cashless transactions.

All the dealers/hoteliers/proprietors registered under the Goa Value Added Tax Act, 2005; The

Central Sales Tax Act, 1956; The Goa Tax on Entry of Goods Act, 2000; The Goa Entertainment Tax Act, 1964 and The Goa Tax on Luxuries Act, 1988 are hereby called upon to ensure that the cashless available modes of payments as stated above are made available at their respective place of business within 10 days from the date of issue of this Circular.

The Commercial Tax Officers in-charge of each Ward shall visit the business places of dealers and verify compliance of above and submit a consolidated compliance report to the undersigned within a fortnight.

Read No. 1. SP/S-Goa/Reader/5470/2016 dated 04-11-2016 from the Supdt. of Police, South Goa, Margao.

2. This office Order No. 37/113/2008/ /Mag/8675 dated 11-08-2016.

Whereas, it is reported by the Superintendent of Police, South Goa District, Margao, that the criminals with an intention of committing crime in Goa, stay in hotels with fictitious names and bogus residential/official address and telephone numbers and after commission of crime, it becomes

very difficult to locate the culprits on the basis of information available in the register of Hotels/Guest House/Inns, and on verification it is found bogus. This is highly risky as terrorist/anti-social elements can camouflage their identity for their operations in Goa. It has become the tendency of landlords/tenants to rent out the premises to anyone without any verification of antecedents and intimation to the local police.

And whereas, being convinced from the information of the Superintendent of Police, South Goa, Margao incidents of crime in District by the persons who come from outside State has increased and from other circumstantial facts, I am of the opinion that there is sufficient ground to take preventive steps to control the movement of criminal in this State. It is felt necessary directions are required to be issued to the Owners/Management of all Hotels, Lodging & Boarding, Private Guest Houses, Paying Guest Accommodation, Temporary Residential Accommodation of all religious bodies.

1. Prohibit any visitors/guest to check-in without providing any identity proof such as Elections Card, Driving License, Smart Card, Employment Card, Adhar Card or any other photo identity card issued by the recognized authority.
2. The in-charges of such accommodation shall provide such facilities for inspection of the records to the Police authorities or any other authority authorize by the undersigned, if so desired by them.
3. They shall also maintain User register.
4. Any suspicious movement/activities noticed from the Users shall forthwith be brought to the notice of the nearest Police Station.
5. The landlord/owner/tenant of the house/property is directed to install CCTV cameras and keep functional 24 X 7 and video footage shall be kept stored for 30 days.
6. The landlord/owner/tenant of the house/property is directed to furnish particulars of the persons to whom accommodation is provided to the jurisdictional Police Station.

And whereas, the circumstances do not permit serving of the notice individually in due time to the concerned, the order is hereby passed ex-parte. It shall be published for information of public through Press and also by affixing copies on the Notice Boards of all Sub-Divisional Magistrates, Mamlatdars and Police Stations.

Therefore, on being satisfied with the report of the Superintendent of Police, South Goa District, Margao, I, Swapnil M. Naik, IAS, District Magistrate, South Goa District, Margao in exercise of the powers vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby order that Owners/Management of all Hotels, Lodging & Boarding, Private Guest Houses, Paying Guest Accommodation, Temporary Residential Accommodation of all religious bodies to prohibit any visitors/guest to check-in without providing any identity proof such as Elections Card, Driving License, Smart Card, Employment Card, Adhar Card or any other photo identity card issued by the recognised authority and also no landlords/tenants/owner/person of any house/property which falls under the territorial jurisdiction of South Goa District, State of Goa shall let/sublet/rent out any accommodation to any person unless and until he/she has furnished the particulars of the tenants to the Police in-charge of the concerned area. Similarly all the persons who intend to take accommodation on rent or otherwise also shall inform in writing in this regard to the in-charge of Police Station of the area in whose jurisdiction the premises fall. Also, the person dealing in property business shall inform in writing to the Police Station in-charge of the nearest Police Station about the particulars of other tenants/purchasers. The above information shall be submitted in duly prescribed forms available in the local Police Station by the landlord within a week.

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

The Supdt. of Police, South Goa District, Margao, Goa, is hereby requested to direct concerned Police Inspectors and SHO's of South Goa District to file report only upon completion of the investigation into the offence i.e. contravening the order issued by the public servant u/s 188 I.P.C. before the Mamlatdar of taluka for filing complaint in writing before the Court for taking cognizance under Section 190 of Cr. P. C.

This order shall come into force with effect from 18-11-2016 and shall remain in operation for a period of 60 days (both days inclusive) unless withdrawn earlier.

The above **SPEED BREAKER** shall be painted with white thermoplastic fluorescent paint and fixed with blinkers for better visibility.

Further, in exercise of the powers conferred on me under Section 116 of the above Act, I also authorise the erection of cautionary signboards "**SPEED BREAKER AHEAD**" at about 40 mts. on either side of the speed breaker in advance of the speed breaker and traffic signboard showing the sign "**SPEED BREAKER**" at the placement of the speed breaker in order to regulate the motor vehicular traffic.

The Secretary, Village Panchayat Ibrampur-Hankhane, Pernem and PWD (Engineering Cell), is directed to publish this notification through the Director of Information and Publicity in local newspapers and to make necessary arrangements to construct the speed breakers and to erect the
